## **Emissions reduction targets**

A. Menarini Farmaceutica Internazionale SRL - UK has no previous emissions reduction commitment, with this being the first year of GHG emissions reporting.

In order to progress to achieving Net Zero, we have adopted the following carbon reduction targets.

It is predicted the carbon emissions will grow by 15% to the end of 2024 due to planned growth of the business. However, following this increase, we commit that net carbon emissions will decrease to 0 tCO<sub>2</sub>e by 2050. This is a reduction of 100%. We will update our performance against this target every year and publish the results on our website

## **Carbon Reduction Projects**

As this is the first year of reporting, there are not yet any new carbon reduction initiatives relating to this CRP.

The company has committed to annual reporting of its GHG emissions and reductions. Annual reporting will be compared against the CRP targets to determine performance, and to highlight further areas of improvement in data collection and operations.

The wider Menarini Group (multinational) has engaged in calculating the carbon footprint at Group level, including the UK division. The objective is to highlight areas of improvement

across the group to streamline their operations as best as possible and improve carbon efficiency across the organisation.

In the future we hope to implement further measures such as:

Transitioning all company car and car allowance drivers to electric vehicles Working with our distribution partners to reduce downstream C02 emissions in our supply chain

Minimising international travel through increased use of electronic meetings Off-setting any remaining carbon emissions

#### **Declaration and Sign Off**
